Fund Description

VanEck Global Listed Private Credit (AUD Hedged) ETF gives investors exposure to a portfolio of 25 of the largest listed companies involved in private credit. LEND aims to provide investment returns before fees and other costs which track the performance of the Index with returns hedged into Australian dollars.

The index measures the performance of the largest and most liquid listed private credit companies.
