Fund Description

The VanEck Vectors Morningstar Wide Moat ETF seeks to replicate as closely as possible, before fees and expenses, the price and yield performance of the Morningstar® Wide Moat Focus Index™. The Index is intended to track the overall performance of attractively priced US listed companies with sustainable competitive advantages according to Morningstar's equity research team.

The Morningstar Wide Moat Focus Index is a rules based index comprised of at least 40 attractively priced US wide-moats stocks, as determined by Morningstar's time-tested proprietary research. According to Morningstar, wide-moat stocks are companies identified as having sustainable competitive advantages.

These changes may result in more diversified exposure, lower turnover, and longer holding periods for index constituents than under the rules in effect prior to 20 June 2016.
